"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of West Stone Avenue in the City of Greenville, being shown as Let B on Map No. 3, recorded in Plat Book "WW" at Page 605, and described as follows:

"BEGINNING at a stake on the Northern side of West Stone Avenue, corner of Lot A, and running thence with the line of said lot, N. 5-30 E. 200 feet to a stake; thence N. 84-30 W. 50 feet to a stake at corner of Lot C; thence with the line of said lot, S. 5-30 W. 200 feet to a stake on West Stone Avenue; thence with the Northern side of West Stone Avenue, S. 84-30 E. 50 feet to the beginning corner."
