(\$2,000.00) , to be paid in monthly instalments of THIRTY AND No/100 -(\$30.00) DOLLARS each, beginning on the 10th day of April, 1948 and continuing on the 10th day of each and every successive calendar month thereafter until the full principal debt has been paid, said payments to be applied first to interest and then to the principal balance due from month to month, with privilege of anticipating payment of any part or all of the principal debt any time before maturity with interest thereon from date

at the rate of Six per centum per annum, to be computed and paid

until paid in full; all interest not paid when due to bear

"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and on the West side of Bob street in the Town of West Greenville, and being known and designated as Lot No. 1 of the property of Minnie B. Christopher. as shown on plat thereof made by Pickell and Pickell, Engrs., on March 2, 1948 and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the Southwest corner of Bob street and a 12-foot alley, and running thence along the West side of Bob street. S. 23-58 W. 47 feet to an iron pin at the corner of Lot No. 2; thence along the line of Lot No. 2, N. 65-37 W. 83.9 feet to an iron pin at the rear corner of said lot in line of other property of Minnie .
