I, William Mayes (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Sullivan Street in the City of Greenville, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin on the Southern side of Sullivan Street at corner of lot formerly owned by Goldsmith, and running thence S. 1-50 W. 135 feet to an iron pin; thence N. 88-10 E. 50 feet to an iron pin; thence N. 1-50 E. 135 feet to an iron pin on the Southern side of Sullivan Street; thence with the Southern side of Sullivan Street, S. 88 W. 50 feet to the beginning corner."
