"BEGINNING at an iron pin on the eastern side of Georgia avenue at the corner of Lot No. 3 now or formerly owned by J. W. Tallent and running thence with the line of said lot, N. 71 E. 177.7 feet to an iron pin on right-of-way of P. & N. Railway Company; thence with said right-of-way, S. 9-30 E. 70 feet to an iron pin corner of other property of C. P.
