(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Four Hundred and No/100- - - - - - - - - DOLLARS (\$ 2400.00), with interest thereon from date at the rate of Six (6%)- - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as the Eastern portion of lot # 22, as shown on a Map of Eastover, prepared by R. E. Dalton, Engineer, July 1920, recorded in Plat Book "F", at Page 42, and being also known as lot # 16, Block 9, Sheet 196 on the County Block Book, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin on Beechwood Avenue, joint front corner of lots # 21 and 22, and running thence N. 20-00 E. 215 feet to an iron pin; thence N. 63-00 W. 67.5 feet to a stake, corner of land, now or formerly, owned by M. 0. long; thence along line of said proterty in a Southwesterly direction 215 feet, more or less, to a point on Beechwood Avenue; thence along Beechwood Avenue, S. 71-55 E. 105.5 feet to the beginning corner.
