"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Flerida Avenue, known and designated as Lot No. 14, Block L, on plat of Highlands, recorded in the R. M. C. Office for Greenville County in Plat Book "K" at Page 51, and having, according to said plat, the following metes and bounds, to-wit:
