"BECINKING at a point on Settlement Bood, 251,5 feet from the center of Rutherford Road, and running themes N. 35-36 E. 431 feet to a pin at certar of lot heretofore conveyed by the mortgager to William H. Andrews: themes with the line of said lot, S. 45-45 E. 100 feet to an iron pin in line of lot # 2; thence along line of lot # 2, S. 35-36 W. 412 feet to a point in Settlement Road; thence along center of said Road, N. 59-30 W. 100 feet to the beginning corner."
