"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of Bouth Carolina, County of Greenville, in Gantt Township, being known and designated as the Northern portion of let # 4 of Unit 2 of Pinecrest Farms as shown on plat thereof recorded in Plat Book "M" at Page 3, and according to a more recent survey prepared by W. J. Riddle, November 6th, 1946, has the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of angusta Road and on the Southern side of Springbrook Drive and running thence with Springbrook Drive, S. 86-35 E. 209 feet to an iron pin, corner of lots # 4 and 5; thence with joint line of said lots, S. 0-38 E. 51 feet to corner of property previously conveyed to the mortgagor; thence with line of said property, N. 89-43 W. 208.8 feet to an iron pin on the East side of Augusta Road; thence along the East-side of said road, N. 0-38 W. 62.5 feet to the beginning corner.
