"BEGINNING at an iron pin on the South side of East North Street 54 feet West of the southwest corner of the intersection of East North Street and Carolina Avenue, joint corner of Cleveland and Putnam, and running thence along the South side of East North Street, S. 76-45 W. 104 feet to an iron pin, joint corner of Cleveland and Edwards, which point is 52 feet East of the Northeast corner of Lot No. 3, Block No. 7; thence with the Edwards line, S. 15 E. 126.1 feet to an iron pin on a 10-foot alley; thence along said 10-foot alley, N. 76-45 E. 104 feet to an iron pin, joint rear corner of Cleveland and Putnam; thence along the Cleveland-Putnam line, W. 15 W. 126.1 feet to the beginning corner Being the same lot of land conveyed to me by Ray Picola by deed dated June 19th, 1948, not yet recorded.
