To All Whom These Presents May Concern:

We, Houston E. Crain and Anne Moore Crain xxxxxxxxxxxx SEND GREETING:

WHEREAS, we the said Houston E. Crain and Anne Moore Crain in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Twenty-five Hundred xxxxxxxxxxxxxxxxxxxxxxxxxxxx (\$ 2500.00 ) Dollars, with interest from the date hereof at the rate of seven per cent ( 7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Forty xxxxxxxxxxxx xxxxxxxxxxxx (\$ 40.00 ) dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said Houston E. Crain and Anne Moore Crain, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about two and one-half miles Northwest from Greer, near Fairview Baptist Church, and being shown and designated as Lot #6 on plat of property of R. B. Vaughn as prepared by H. S. Brockman, Surveyor, June 26th, 1940, and having the following courses and distances, to wit:-

BEGINNING on iron pin on the Northwest side of Road that was formerly known as the Mosteller Road and which now connects the Buncombe Road and the Gilreath Mill Road, and runs thence with the said road N 47-24 E 140 feet to iron pin on the bank of the said road, joint corner of Lots 6 and 7; thence with the line of Lot #7 N 44-59 W 254 feet to iron pin on the South side of a proposed 20 foot road, joint corner of Lots 6 and 7; thence with the Southern side of the proposed 20 foot road S 45-09 W 140 feet to iron pin, joint corner of Lots 5 and 6; thence with the line of Lot #5 S 45-01 E 248.5 feet to the beginning corner. This is the same property conveyed to us by E. R. Minus, Sr. by DEED dated May 6, 1948.
