Holcombe:- All thatv certain piece, parcel or lot of land lying and being in Austin Township, County and State aforesaid, located in the Town of Simpsonville on the west side of an old stage road(Now Maple Street) and adjoining lands now or formerly owned by S. T. Pollard, J. E. Jones and others, and beginning at the corner of a lot formerly known as lot # 6, and running thence N. 16 1/2 W. 151 ft. to a stone; thence along the line of property now or formerly owned by Mrs. Cox a distance of 50 ft. to a stake; thence in an easterly direction 151 ft. to the stage road(Maple Street) at a point 50 ft. from the starting point; thence up the said Maple Street 50 ft. to the beginning corner, being the same lot as is being this day conveyed to mortgagor by Margaret A.
