All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, containing 15.8 acres, more or less, according to survey and plat by W. J. Riddle, February 15, 1945, being situate on the West side of the Old Easley Bridge Road, and more particularly described as follows:

BEGINNING at a stake in said Road, corner of property conveyed to E. R.
