in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said South Carolina National Bank

all that tract or lot of land in Butler Township, Greenville County, State of South Carolina.

All that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, School District 7-B, being known and designated as Lot No. 53 of a subdivision known as "Vista Hills", according to a survey and plat of the same prepared by Dalton and Neves, Engrs., May, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P, page 39, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Kent Lane at the joint front corners of Lots Nos. 52 and 53, said pin being 160 feet North from the Northeast corner of the intersection of Kent Lane with a county road; thence along the joint line of said Lots Nos. 52 and 53, N. 88-10 E. 175 feet to an iron pin at the joint rear corners of said lots; thence along the rear line of Lot No. 53, N. 1-50 W. 70 feet to an iron pin at the joint rear corners of Lots Nos. 53 and 54; thence along the joint line of said Lots Nos. 53 and 54, S. 88-10 W. 175 feet to an iron pin on the East side of Kent Lane at the joint front corners of said lots; thence along the East side of Kent Lane, S. 1-50 E. 70 feet to the beginning corner; being a portion of the property conveyed to Central Realty Corporation by L. T. Batson by his deed dated June 27, 1945, recorded in the R. M. C. Office for Greenville County

in Deed Vol. 277, page 256.
