, to be paid six months after date

, with interest thereon from date

at the rate of 5 per centum per annum, to be computed and paid Semi-annually

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

D. L. Bramlett, Jr. and Elizabeth B. Hughes, Executors of the Estate of D. L. Bramlett, Deceased:- All that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, Greenville County, S. C. located on the South-East side of Decatur Drive, being designated as lot # 11 of a subdivision of Property of D. L. Bramlett, as shown on a plat made by W. J. Riddle, Surveyor on March 17, 1937, said plat being recorded in Greenville County R. M. C. Office in Plat Book "I", page 139, and more fully described as follows:-

Beginning at an iron pin on the South-East side of Decatur Drive at corner of lot # 10, and running thence along line of lot # 10, S. 33-15 W. 243.7 ft. to iron pin, joint back corner of lots 10, 17, & 18; thence along line of lot # 17 S. 68-37 W. 85.4 ft. to iron pin, corner of lots 12, 16 & 17; thence along line of lot # 12 N. 32-53 W. 129.2 ft. to pin on Decatur Drive; thence along South-East side of Decatur Drive N. 58-32 E. 80 Ft. to the Beginning corner.

This is the same lot as is today being conveyed by mortgagees to mortgagor, deed not yet recorded, and this instrument is being given to secure a balance due on the purchase price of said lot.
