We, W. L. VAUGHAN, E. C. TRAMMELL, and H. H. KERNS,  
as Local Trustees of TREMONT AVENUE CHURCH OF GOD, an unincorporated association in the State and County aforesaid,  
SEND GREETINGS :

Whereas, we, the said Trustees were duly authorized by proper resolution in accordance with the Book of Church Government of the Church of God to borrow money and pledge the property of the Church therefor; and,

Whereas, pursuant to said resolution, we, the said Trustees have borrowed the sum of Seventy-Five Thousand and No/100 (\$75,000.00) Dollars from CAROLINA LIFE INSURANCE COMPANY of Columbia, South Carolina, and have made and delivered therefor our promissory note, as Trustees aforesaid, in writing, of even date herewith, of which the following is a copy:

"On the 1st day of October, 1958, for value received, W. L. VAUGHAN, E. C. TRAMMELL and H. H. KERNS, as Local Trustees of TREMONT AVENUE CHURCH OF GOD, or their successors in office, promise to pay to the order of CAROLINA LIFE INSURANCE COMPANY the principal sum of Seventy-Five Thousand and No/100 (\$75,000.00) Dollars, with interest thereon, from date hereof at the rate of four (4%) per cent. per annum, said interest to be paid monthly, commencing on the 1st day of November, 1948, and continuing on the 1st day of each and every month thereafter until said principal sum has been paid in full; all installments of interest and the principal of this note being payable at the Home Office of the CAROLINA LIFE INSURANCE COMPANY, at Columbia, South Carolina, in lawful money of the United States of America.

"This note and the interest are secured by a mortgage on real estate of even date herewith duly recorded in the office of the Register of Mesne Conveyances for Greenville County, South Carolina.

"If this note is placed in the hands of an attorney for collection, by suit or otherwise, or to enforce its collection, or to protect the security for its payment, the makers will pay
