"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the South side of Bradley Boulevard, about 1 mile from the corporate limits of the City of Greenville, and being known and designated as lot # 36 on plat of the property of College Park Realty Corporation, known as University Park, made by Dalton & Neves, dated November 26, 1946, recorded in Plat Book "F" at age 127, and having the following metes and bounds, to-wit:
