We, J. W. Finley and Ruth C. Finley

Whereas, we the said J. W. Finley and Ruth C. Finley

in and by our certain Promissory note in writing, of even date with these presents, are well and truly indebted to Citizens Lumber Company

in the full and just sum of Thirty-Five Hundred and No/100 (\$3500.00) Dollars, to be paid in monthly installments of \$35.00 each on the 1st day of each month hereafter beginning January 1, 1949, said payments to be applied first to the payment of interest and balance to principal until paid in full

with interest thereon from date at the rate of Six per cent. per annum, to be computed and paid semi-annually monthly

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten (10%) per cent. of the amount due thereon, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That the said Mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, and its successors Heirs and Assigns forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in Greenville Township, Greenville

County, State aforesaid, on the Western side of Mary Street, near the City of Greenville, being shown as lot # 104 on Map # 2 of Camilla Park made by W. J. Riddle in December 1943, recorded in Plat Book "M" at Page 85, and described as follows:

BEGINNING at a stake on the Western side of Mary Street, 286 feet South from Flora Avenue, at corner of lot # 103 and running thence with line of said lot, S. 67-50 W. 163 feet to a stake in line of lot # 100; thence with line of said lot, S. 9-28 E. 80.7 feet to a stake at corner of lot # 105; thence with line of said lot, N. 70-35 E. 176.3 feet to a stake on Mary Street; thence with the Western side of Mary Street, N. 19-25 W. 86 feet to the beginning corner.
