WHEREAS we, Sue Moore, Hubert Moore, Edith Moore Stewart, and Correne Moore Sloan; are

well and truly indebted to

in the full and just sum of Nine Hundred & No/100 (\$900.00) - - - - - Dollars, in and by our certain promissory note in writing of even date herewith, due and payable

\$25.00 with the privilege to pay not exceeding \$50.00 on the first day of each and every month hereafter, commencing December 1, 1948. Payments applied first to interest, balance to principal, balance due five years from date, with the privilege to anticipate part or all after one year,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said Sue Moore, Hubert Moore, Edith Moore Stewart & Correne Moore Sloan in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

C. E. Robinson as Trustee under B. M. McGee Will, his successors and assigns, forever:

All these pieces, parcels or lots of land in Greenville Township, Greenville County, State of South Carolina, lying and being on the North side of Mahon Street and being known and designated as Lots Nos. 13 and 14 of Block C of Park Place, as shown on Plat thereof recorded in the S. C. Office for Greenville County, S. C., in Plat Book "A", Page 213, and having according to said plat the following metes and bounds, to-wit:

Beginning at a stake on the northern side of Mahon Street, at the corner of a 10 foot alley and running thence along the northern side of Mahon Street, S. 10-15 W. 120 feet to a stake joint front corner of Lots Nos. 14 and 15; thence with the joint line of Lots Nos. 14 and 15, S. 0-17 W. 111 feet to a stake on another 10 foot alley; thence along the south side of said alley, S. 33-15 W. 114.3 feet to a stake on the southern corner of the intersection of the last mentioned alley with the first mentioned alley; thence along the first mentioned alley, S. 0-17 W. 137 feet to the beginning corner.

The above two lots were conveyed to C. E. Moore by two separate deeds, Lot No. 13 being conveyed to him by deed recorded in Deed Book 131, Page 62, S. C. Office for Greenville County, S. C., and Lot No. 14 by deed recorded in Deed Book 136, Page 314, S. C. Office for Greenville County, S. C. The said C. E. Moore subsequently died on April 1st, 1933, leaving as his sole heirs and distributees his widow, Sue Moore and three children, Hubert, Edith and Correne Moore, all of whom are now more than 21 years of age.
