All that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, State of South Carolina, in Gantt Township, lying and being on the Conestee Road and also on the Fork Shoals Road, and having the following metes and bounds, to-wit:

Beginning at an iron pin at the southwest corner of a tract belonging to the Greenville Gun Club, and in the line of property of Henry Willimon Estate and running thence N. 88-59 W. 831.6 feet to a C. I. Monument; thence S. 76-42 W. 757.6 feet crossing the Fork Shoals Road to a C. I. Monument; thence N. 26-13 E. 255 feet recrossing the Fork Shoals Road to a White Oak and an iron pin; thence N. 26-18 E. 993 feet to an iron pin; thence N. 26-03 E. 357 feet to an iron pin, corner of property belonging to Tzouvelekas; thence with his line, S. 53-37 E. 190 feet to iron pin, corner of cemetery property; thence with joint line between him and the cemetery property, N. 36-05 E. 340.7 feet; thence S. 68-19 E. 228 feet to iron pin in center of Second Street; thence along center of Second Street, S. 49-11 W. 110 feet; thence still along the center of said Street, S. 34-53 W. 246 feet; thence still with center of said street, S. 57-01 W. 120 feet; thence S. 30-44 E. 1220 feet, more or less, to the beginning corner.
