A. Ellis Surveyor, June 10, 1946, and having the following metes and bounds to wit; TEGITHING at a corner on Alverson's line 269 feet East of Let No. 2, and running thence S. 93 E. 380 feet to corner of lot No. 6, thence N. 3 E. 876 feet to corner of Lot No. 6; thence with Lot No. 5, N. 98 W. 190 feet to corner of Lot No. 4; thence S. 15½ W. 840 feet to beginning corner.
