Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto City Savings Bank, Charlotte, North Carolina

organized and existing under the laws of the State of North Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixty-six Hundred - - - - - Dollars (\$ 6600.00 ), with interest from date at the rate of four per centum ( 4 % ) per annum until paid, said principal and interest being payable at the office of City Savings Bank, Charlotte, N. C. in Charlotte, N. 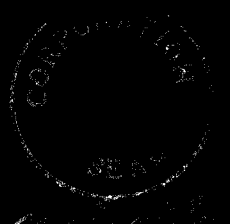
All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the East side of West Fairview Avenue in that area recently annexed to the City of Greenville in Greenville County, South Carolina, being shown as Lot 36 on Plat of Druid Hills made by Dalton & Neves, Engineers, January, 1947, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book P, page 113, said lot fronting 50 feet on the East side of West Fairview Avenue with a depth of 209 feet on the North side, a depth of 208 feet on the South side, and being 129.6 feet across the rear and is located 333.9 feet South from Rutherford Road (also known as U. S. Highway 29 Alternate).

The above described property is a part of the same conveyed to the Mortgagor by deed of Jessie F. Welter, dated August 7, 1946, recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 297, page 63.
