MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **Essie M. Miller** . (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Bank of Travelers Rest, Travelers Rest, S. C.**, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Three Thousand and No/100- - -**

DOLLARS (\$ 3,000.00),

with interest thereon from date at the rate of **six** per centum per annum, said principal and interest to be repaid: On or before **July 27, 1949.**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of **Three (\$3.00) Dollars** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in Ward **One of the City of Greenville, and described as follows:**

"BEGINNING at a stake at the Northwest corner of Buncombe and James Streets; thence along the North side of James Street, N. 61-18 E. 176.8 feet to stone pillar; thence along line of W. C. Cauble, N. 25-0 W. 115.8 feet to the intersection of two fences; thence with a fence along property now or formerly owned by T. R. Chatham, S. 56-31 W. 193.7 feet to stake at the end of a brick wall on the east side of Buncombe Street; thence along the east side of said Street, S. 33-57 E. 100 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by Mary E. McKay and Chas. M. McGee, Trustees under the Will of Chas. E. McKay, deceased, by deed recorded in Book of Deeds 68 at Page 88.
