DOLLARS (\$ 4,000.00),

with interest thereon frameworks at the rate of five (5%)per centum per annum, mathematical transfer to be repaid: in monthly installments of \$75.00 each on the first day of each month hereafter, beginning May 1, 1949; payments to be applied first to interest and then to principal until May 1, 1950, at which time the entire balance shall become due and payable; with full privilege of anticipating all or any part of the unpaid balance at any time, with interest thereon from May 1, 1949, to be computed and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, known and designated as Let No. 4, Block K of Fair Heights, as shown on Plat recorded in Plat Book F at Page 257, and having, according to said Plat, the following metes and bounds, to-wit:
