To all Whom These Presents May Concern:

WHEREAS I, Matilda Kilgore, of Greenville County, am well and truly indebted to L. A. Mills

in the full and just sum of Three Hundred and No/100 - - - - - (\$ 300.00) Dollars,

in and by my certain promissory note in writing of even date herewith, due and payable as follows: in monthly instalments of TWENTY-FIVE AND NO/100 - (\$25.00) DOLLARS each, beginning on the 16th day of April, 1949 and continuing on the 16th day of each and every successive calendar month thereafter until the principal debt has been paid in full, said payments to be applied first to interest and then to the principal balance due from month to month

with interest from date at the rate of six per centum per annum until paid; interest to be computed and paid Monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Matilda Kilgore

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said L. A. Mills, his heirs and assigns forever:

"All that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township on the South side of Rutherford Road, and being known and designated as Lot No. 8 of a subdivision known as Rutherford Park, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book P, at page 109, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the South side of Rutherford Road at the corner of Lot No. 7, which point is approximately 348.3 feet Northeast of the intersection of Foster Street, and running thence along the line of Lot No. 7, S. 16-22 E. 152.4 feet to an iron pin at the rear corner of said lot in the line of Lot No. 24; thence along the line of that lot, N. 52-04 E. 28.7 feet to an iron pin at the rear corner of Lot No. 9; thence along the line of Lot No. 9, N. 17-30 W. 145 feet to an iron pin at the corner of said lot on the South side of Rutherford Road; thence along the line of Rutherford Road, S. 66-57 W. 50 feet to the beginning corner; being the same lot of land conveyed to me by L. A. Mills by deed of even date herewith, not yet recorded."

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises unto the said

L. A. Mills, his Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, his Heirs and Assigns, from and against me, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.
