WHEREAS, the Mortgagor is well and truly indebted unto  
LIBERTY LIFE INSURANCE COMPANY

, a corporation  
organized and existing under the laws of South Carolina , hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Thirty Nine Hundred -  
Dollars (\$ 3900.00 ), with interest from date at the rate of four and one-half per centum  
( 4½ %) per annum until paid, said principal and interest being payable at the office of Liberty  
Life Insurance Company in Greenville, S. C. ,

lying and being in Dunean Mills Village, Greenville County, South Carolina, and

Pickell, Engineers, Greenville, S. C., on June 7, 1948, revised June 15, 1948, and

described lot is also known as No. 35 Blake Street (Avenue)  
and fronts thereon 79 feet.
