"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Boling Circle and being known and designated as Lots Nos. 122 and 123 of a subdivision of property of Charlotte A. Tripp, known as Brewertown as shown on a Plat thereof by Fitzpatrick-Terry Company, Engineers, dated June, 1920, recorded in the R. M. C. Office for Greenville County in Plat Book "E", Page 254, and having according to said Plat the following metes and bounds, to-wit:
