We, Roy B. Gibson and Madge C. Gibson, of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

All that piece, parcel or lot of land with the improvements thereon situate lying and being in **Duncan Mills Village, Greenville County, South Carolina**, and being more particularly described as Lot No. **34**, Section **3**, as shown on a plat entitled "Subdivision for Duncan Mills, Greenville, S. C.", made by **Pickell & Pickell, Engineers, Greenville, S. C.**, on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the R. M. C.
