all that tract or lot of land in Gantt Township, Greenville County, State of South Carolina, known and designated as Lot No. 139 according to property of Woodfields, Inc., located on the southwest side of Augusta Road as shown by plat of property of Woodfields, Inc., plat made by C. C. Jones in October, 1947, and having, according to said plat, the following metes and bounds, to-wit:
