Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being at the Northeast corner of the intersection of Beck Avenue and Long Hill Street, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot #98 on plat of Augusta Road Ranches, made by Dalton & Neves, Engrs. April 1941, recorded in R. M. C. Office for Greenville County, S. C. in Plat Book M, page 47, (also recorded in Plat Book L, pages 52 and 53), and having according to said plat and a recent survey made by A. C. Crouch, Engineer, May 4, 1949, the following metes and bounds, to-wit:
