Whereas, I, the said Mrs. Ila Mae Stone

in and by my certain promissory note in writing, of even date with these Presents, I am well and truly indebted to Bank of Piedmont

in the full and just sum of Thirty Five Hundred and NO/00  
to be paid

Payable one year from date

with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, and known as lot #6 and adjoining lot #7, and having the following metes and bounds according to said plat, to wit:

Beginning at an iron pin on Highway # 29 at corner of lot # 7 and running thence along line of said lot # 7 approximately N.26 W.218 feet, more or less, to an iron pin on driveway; thence along said driveway S.77 W.171 feet to a post at corner of lot owned by Garrett, formerly Grover; thence along line of said Garrett lot S.19 E.264 feet to a fence corner at edge of ten foot driveway; thence N. 76 E. 182 feet to the beginning corner. This is the first lot of land described in the deed by J.F. Murphree to the Grantor dated March 6, 1944, and recorded in deed book 266, page 148, and in the correcting deed by J.F. Murphree to the Grantor 1944, recorded in deed book 267, at page 210.
