WE, WOODROW GREENWAY AND GERALDINE C. GREENWAY, of
Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation
organized and existing under the laws of **South Carolina**, hereinafter

sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville** ,
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,
lying and being in Monaghan Mills Village, Greenville County, South Carolina, and
being more particularly described as Lot No. **89** , Section **3** , as
shown on a plat entitled "Subdivision for Victor-Monaghan Mills, Greenville,
S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., on December 20,
1948, and recorded in the R. M. C. Office for Greenville County in Plat Book S, at
Pages 179-181, inclusive. According to said plat, the within described lot is also
known as No. **27** **Donaldson** Street (Avenue)
and fronts thereon **68** feet.
