WE, PRESTON S. HOLTZCLAW AND ESTELLE S. HOLTZCLAW, of
Greer, S. C. , hereinafter called the Mortgagor, send (s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Greer

if not sooner paid, shall be due and payable on the first day of **July** , 19 **64** .

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,
lying and being in or near the City of Greer, Greenville County, South Carolina,
and being more particularly described as Lot No. 27, as shown on a plat en-
titled "A Subdivision for McCall Manufacturing Company, Greer, S. C.", made by
Pickell & Pickell, Engineers, Greenville, S. C., May, 1949, and recorded in the
R. M. C. Office for Greenville County in Plat Book S, at page 76. According to said
plat the within described lot is also known as No. 102 Franklin
Street (Avenue) and fronts thereon 83 feet.
