Whereas, I, the said C. B. Cole, Jr.

, to be paid six months after date

, with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid semi-annually

until paid in full: all interest not paid when due to bear

interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,

sold and released, and by these Presents do grant, bargain, sell and release unto the said

Farmers Bank of Simpsonville: All that piece, parcel or lot of land lying and being in Austin Township, County and State aforesaid, in the Town of Simpsonville, on the south side of South Pliney Circle, known and designated as lot # 31 on the subdivision known as League Estates according to a map thereof made by W. J. Riddle, Surveyor, dated October, 1941, recorded in R. M. C. Office for Greenville County, S. C. in Plat Book K, pages 111 and 112, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of South Pliney Circle, at the northeast corner of lot number 32, and running thence with the line of lot number 32, S. 19-00 E. 154.7 ft. to a pin; thence N. 55-30 E. 111.6 ft. to corner of lot number 30; thence with the line number 30, N. 19-00 W. 147 ft. to a pin on South Pliney Circle; thence with the southern side of south pliney circle, S. 59-30 W. 110 ft. to the beginning corner.

This is the same land conveyed to me by W. Marion Kirby, Jr. by deed dated July 27, 1946, recorded in Deed Book 297, Page 18, R. M. C. Office, Greenville County.
