"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the East side of McBee Boulevard, and being known and designated as a portion of lots Nos. 13 and 14, of Block B, of Vardry Heights, as shown on a plat recorded in Plat Book A, at Pages 122 and 123, and being more particularly described as follows:
