

M. C. Office for Greenville County in Plat Book 0, at page 103, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of a county road at the corner of Lot No. 10, which point is 260.8 feet south of the intersection of Hallton Road, and running thence along the rear line of Lots Nos. 10, 11, 12 and 13, N. 33-30 E. 896.6 feet to an iron pin at the rear corner of Lot No. 20% thence along the line of Lot No. 20% S. 50-12 E. 613 feet to an iron pin on the North side of a country road; thence along said county road, S. 64-30 W. 155 feet to an iron pin; thence still along the line of said county road, S. 68-00 W. 485.4 feet to an iron pin; thence still along the line of said county road, S. 60-25 W. 248.2 feet to an iron pin; thence S. 69-29 W. 130 feet to an iron pin on said county road; thence still along the line of said county road, N. 31-54 W. 72 feet to the beginning corner.
