C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Caklawn

Township, on the West side of U. S. Highway No. 29 and being known and designated as Lots Nos. 34 and 35 of the T. D. B ennett sub-division, as shown by plat made by G. Sam Lowe, Registered C.E., dated August 24, 1948 and recorded in A. . . Orrice for Greenville County in Plat Book S, page 143, and according to said plat more perticularly described as follows:-

BEGINATING at a point in the line of the Felzer lanufacturing Company on the northern side of Bennett Street and running thence well-55 E with the northern edge of Bennett Street 75 feet to the joint corners of Lots Nos. 35 and 36; thence NO-50E 335 feet to the joint corners of Lots Nos. 35 and 36; thence N 89-15 W 150 feet to the joint back corners of Lots Nos. 77 and 78; thence S 12-20 E 355 feet to the beginning corner.
