All those certain pieces, parcels or lots of land with the buildings and improvements thereon, situate, lying and being on the North side of the Jervey Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lots 1, 2 and the western 5 feet of Lot 3 adjacent thereto, on Plat of property of L. A. Moseley made by Madison H. Woodward, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book B, pages 144 and 145 and having according to said plat and a recent survey made by J. C. Hill, Surveyor, August 4, 1949, the following metes and bounds, to-wit:
