, a corporation South Carolina , hereinafter organized and existing under the laws of called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixty-Two Hundred and No/100 ), with interest from date at the rate of Four & One-Hal f Dollars (\$ 6200.00 (  $4\frac{1}{2}\%$ ) per annum until paid, said principal and interest being payable at the office of Fidelity in Greenville, S. C. Federal Savings & Loan Association or at such other place as the holder of the note may designate in writing, in monthly installments of Thirty-Nine and 25/100----- Dollars (\$ 39.25) December , 19 49, and on the first day of each month therecommencing on the first day of after until the principal and interest are fully paid, except that the final payment of principal and interest, ,19 69. if not sooner paid, shall be due and payable on the first day of November

Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville . State of South Carolina: in Gantt Township, on the Fork Shoals Road, about  $5\frac{1}{2}$  miles from the City of Greenville and being more particularly described according to an unrecorded plat of J. C. Hill, October 20, 1949, as follows:

"BEGINNING at a point in the center of the intersection of the Fork Shoals Road with a private County Road adjacent to Mrs. Garrison's lands, and running thence with saidCounty Road, S. 80-45 W. 33.3 feet to a bend in road; thence S. 58-17 W. 153.6 feet to an iron pin; thence S. 11-03 E. 105.2 feet to an iron pin in line of property of J. Rowley Henderson; thence with J. Rowley Henderson's property line, N. 66-37 E. 288 feet to a point in center of Fork Shoals Road; thence with said road, N. 58-23 W. 142.2 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by J. Rowley Henderson by two deeds dated May 6th and May 21st, 1948, and recorded in Volume 345 at Page 451 and Volume 349 at Page 354 respectively.

ALSO, one 50-Gallon Electric Water Heater, one Metal Kitchen Sink Unit, it being the intention of the mortgagor that said chattels shall constitute a part of the real estate.
