AMORTIZATION MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That F. L. RIDDLE  
of the County and State aforesaid, hereinafter called

first party, whether one or more, SEND GREETINGS:

WHEREAS, first party is indebted to The Federal Land Bank of Columbia, a corporation created, organized and existing under and by virtue of an Act of Congress, entitled the Federal Farm Loan Act, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of TEN THOUSAND -

(\$ 10,000.00 ) Dollars,

payable to the order of the second party, together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of four and 1/2 (4 1/2%) per centum per annum (or at the rate of interest fixed by Act of Congress), the first payment on interest being due and payable on the

first day of November, 1945, and thereafter interest being due and payable annually; said principal sum being due and payable in Twenty-nine equal, successive, annual installments of Three Hundred Thirty-four - (\$ 334.00 )

Dollars each, and a final installment of Three Hundred Fourteen - (\$ 314.00 ) Dollars, the first installment of said principal being due and payable on the

first day of November, 1945, and thereafter the remaining installments of principal being due and payable annually until the entire principal sum and interest are paid in full, and each installment of principal and interest bearing interest from due date until paid at the highest rate authorized to be charged under the Federal Farm Loan Act, as amended; all of which and such other terms, conditions and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell, and release, in fee simple, unto second party, its successors and assigns, the following described lands, to wit:

All that piece, parcel and lot of land lying and being in Gantt and Grove Townships, Greenville County, State of South Carolina, and being made up of four separate tracts of land which lie adjoining each other and which consist of One Hundred Fifty-six and 87/100 (156.87) acres, according to a plat made by J. Mac Richardson, Reg. Land Surveyor, in November 1949. Said tract of land is bounded on the North by the Air Base and Willimon, on the East by Willimon and the Fork Shoals Road with Ashmore across the road, on the South by Bramlett, Ashmore and Harris, and on the West by Harris and Payne. Said tract of land is fully shown by courses and distances and metes and bounds on the Richardson plat, recorded in Flat Book L Page 2, R. M. C. Office, Greenville County.

Notwithstanding any provision herein, or in the note secured hereby, to the contrary, first party may make at any time advance payments of principal in any amount. Advance principal payments made within five years from the date hereof may be applied, at the option of second party, in the same manner as those made after five years from the date hereof.
