NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing 36.93 acres, more or less, as shown on an unrecorded plat of the property of Daisy Batson and sisters, prepared by W. A. Hester in 1938, and being more particularly described as follows:

**BEGINN ING at a point in the Keeler Mill Road, corner of lands now owned by Buford Peterson and Lula Stone and the mortgagor and running thence N. 59 E. 20.40 chs. to a corner (Maple gone); thence S. 18 E. 3.41 chs. to a stone; thence S. 56 W. 10 chs. to a stake; thence S. $50\frac{1}{2}$ E. 13.50 chs. to a stone; thence S. $31\frac{1}{2}$ E. 13.87 chs. to an iron pin in corner of land of Lucy Mae Jewel; thence S. $77\frac{1}{2}$ W. 6.64 chs. to an iron pin; thence due South 1.52 chs. to an iron pin; thence S. $65\frac{1}{2}$ W. 4.14 chs. more or less to a point in the fork of the roads; thence in a Northerly direction up the Keeler Bridge Road 28 chs. more or less to the beginning corner.
