WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near the limits of the City of Greer, on the North side of James Street, designated as Lot No. 9 of the I.M. Wood Property, according to survey and plat by H.S. Brockman, Surveyor, dated December 31, 1929, and having the following courses and distances, to wit: Beginning at an iron pin on James Street, corner of Lot No. 8, and running thence N. 76.41 W. 54 feet to corner of Lot No. 10; thence along the line of Lot No. 10, N. 8.47 E. 169.2 feet; thence S. 82.25 E. 58 feet to corner of Lot No. 9; thence along the line of Lot No. 8, S. 10.15 W. 174.8 feet to the beginning corner.

Together will all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
