TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, W. G. Hayes and Lillie Owens Hayes

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Seven Hundred and No/100- - - - -

DOLLARS (\$ 4700.00), with interest thereon from date at the rate of Six (6%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the Eastern side of Waddell Street, being shown as all of lots 76, 77, 97, 96 on plat of B. Perry Edwards recorded in Plat Book F, at Page 143, and a tract of land lying between the rear line of lots Nos. 97 and 96, and the branch also being shown as lots Nos. 13, 14, 33, 34 of Block 3, Page P-13, and lot No. 23 of Block 4, Page P-13 of County Block Book, and when described as a whole has the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Waddell Street, at joint front corner of lots Nos. 77 and 78, as shown on plat recorded in Plat Book F, Page 143, and at joint corner of property of mortgagors and that of G. M. Davis and Perdella Davis, and running thence with line of Davis property, S. 88 1/2 E. 680 feet more or less to pin on branch; thence down center of said branch as a line 161 feet more or less to pin; thence N. 88 1/2 W. 680 feet more or less to pin on Waddell Street; thence with the Eastern side of Waddell Street, N. 0-42 E. 160.4 feet to corner of Davis property, the point of beginning."

Being the same premises conveyed to the mortgagors by deed recorded in Volume ___ a t Page ___.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
