All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Southeast side of East Farris Road, being known and designated as Lot No. 54 of a subdivision known as Forest Heights, and the property herein conveyed is described according to a plat of the aforementioned subdivision recorded in the R.M.C. Office for Greenville County, S.C. in the Plat Book P, at Page 71. Said property has the following metes and bounds, courses and distances, to wit:

Beginning at an iron pin on the Southeast side of East Farris Road, at the joint front corner of Lots No. 53 and 54, and running thence along the common line of said Lots S. 25-30 E 100 feet to an iron pin at joint rear corner of Lots No. 52 and 53; thence along the rear line of Lot No. 52, S. 55 E. 65 feet to an iron pin joint rear corner of Lots No. 51 and 52; thence along the rear corner of Lots No. 51, N. 81-39 E. 86.5 feet to an iron pin joint rear corner of Lots No. 50, 51 and 54; thence N. 27-04 W. 182.5 feet to an iron pin on the Southeast side of East Farris Road; thence along the Southeast side of East Farris Road, S. 64-30 W. 110 feet to an iron pin, the beginning corner, with the improvements thereon.
