All that certain piece, parcel or lot of land with the buildings an improvements thereon situate, lying and being on the South side of Potomac Avenue, in that area recently annexed to the City of Greenville, in Greenville County, Bouth Carolina, being shown as Lot No. 244 on plat of Pleasant Valley, made by Dalton & Neves, April 1946, revised May 1948 recorded in the R.M.C. Office for Greenville County, D. C. in Plat Book P, page 93, and having according to said plat the following metes and bounds, to-wit:
