"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ... Graenville, ...and .in .Greenville Township, known and designated as Lot No. 10 on Map No. 2 of Camilla Park Subdivision, property of John B. Marshall Estate, which map is recorded in the R. M. C. office for Greenville County in Plat Book "M", at page 85, and having, according to said map, the following metes and bounds, to-wit:

"BEGINNING at the southeastern intersection of the Easley Bridge Road and Harvard Avenue, and running thence S. 60-51 E. 200 feet to the corner of Lot No. 58; thence S. 27-40 W. 80.7 feet to the corner of Lots Nos. 57 and 11; thence N. 60-51 W. 202.5 feet to a point on the Lasley Bridge Road; thence N. 29-09 E. 80 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
