All that certain tract of land in Butler Township, Greenville County, State of South Carolina, on the south side of the Woodruff Road, near the City of Greenville, being the major portion of Lot No. 4 on Plat of Property of E. R. Haynie made by P. B. Wilson, Jr., Surveyor, October 1945, and having the following metes and bounds:
