All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northeast side of Rock Creek Drive in that area recently annexed to the City of Green-ville in Greenville County, South Carolina, being shown as Lot No. 10 on plat of property of Elizabeth G. McCall, made by Dalton & Neves, Engineers, April 1940, and having according to said plat and a recent survey made by R. W. Dalton, Surveyor, January 10, 1950, the following metes and bounds, to-wit:
