All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, beginning at an iron pin at the southwest intersection of Douglas Avenue and Huff line and running thence along the western side of Huff line S. 6° 48' E. for a distance of one hundred (100') feet, more or less; thence turning and running N. 86° 29' W. for a distance of one hundred thirty-eight and seven-tenths (138.7') feet, more or less; thence turning and running in a northeasterly direction one hundred (100') feet, more or less, to the said Douglas Avenue; thence turning and running S. 86° 29' E. for a distance of one hundred twenty-five (125') feet to the point of beginning.
