in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The Peoples National Bank of Greenville, South Carolina

(1) all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina. on the North side of Cherry Avenue (Hillcrest Drive) now inside the City of Greenville, shown as Lots Nos. 18 and 19 on a plat of the property of Hicks and Jackson made by R. E. Dalton, Engineer, June, 1940, said plat recorded in the R. M. C. Office for Greenville County in Plat Book E, at page 258, and having the following metes and bounds, to-wit:

Beginning at a stake on the North side of Cherry Avenue (Hillcrest Drive) corner of Lot No. 17, and running thence with line of said lot N. 43-19 E. 140.2 feet to stake; thence N. 46-34 W. 50 feet to stake, corner of Lot No. 20; thence with line of Lot No. 20, S. 43-19 W. 140.3 feet to stake on Cherry Avenue (Hillcrest Drive); thence with Cherry Avenue (Hillcrest Drive) S. 46-41 E. 50 feet to the beginning.
