until paid in full: all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that parcel or lot of land situated and being in Oneal township of Greenville, South Carolina, about four miles Northwest from the City of Greer and about two miles from Double Springs Baptist Church, being all of tract or lot No. 6 on a plat of property made for the estate of J.B. Brookshire by H.L. Dunahoo, Surveyor, dated September 21, 1946, recorded in the R.M.C. Office for Greenville County in Plat Book "P", at page 89, reference thereunto being made for a detailed and complete description of said lot. Said lot has the following courses and distances:

BEGINNING at a stake at the intersection of the Buncombe Road and Old Rutherford Road, and runs thence with the South side of the Buncombe Road N. 61.30 W. 275 feet to a stake, corner of tract No. 5; thence with line of tract No. 5 300 feet to a stake on line of tract No. 21; thence with the line of tract No. 21 S. 61.30 E. 175 feet to a stake on the West side of the Old Rutherford Road; thence with the west side of said road in a northerly direction 312 feet to the beginning corner, containing 1.55 acres, more or less, and being the identical property conveyed to ~~W.D.~~ W.D.
